Bison's Hip Hop is a training program that the Mi Competitive Team Dancers are attending one weekend per month for a 6 month period. The program instructor travels to RMWB to bring the program to the dancers so that the dancers do not have to travel outside of our region. It is a program designed to enhance hip hop skills at a highly competitive level and create choreography that will garner success at this level. We were fortunate to secure the services of National Team Coach, Mr. Paul Otterbein.	
Mr. Otterbein has trained several of our individual dancers for international competition over the last few years and saw such talent in our region, that he agreed to assist our team as a whole! Last year, under his guidance, one of our dance teams became the Alberta Representative earning an invitation to the Hip Hop International Competition that was held in Montreal, PQ. Without having this program running in the RMWB, our dancers would never realize these goals and opportunities. Our dance program has expanded from 4 to 5 teams for this season and we have high hopes for even more dancers to experience this type of success.	
Recently, 2 of our graduate hip hop dancers have been accepted to professional teacher training programs in /ancouver with the hopes of one day being able to support or supplement this type of training within the RMWB. Four other advanced or graduate hip hop dancers are currently gaining teaching experience within the MI Dance academy as instructors for their recreational hip hop programs. Therefore, it is easy to see the far-reaching benefit this program has to our community.

I am writing this reference letter on behalf of the MacDonald Island Competitive Team Association, as their tenacity and commitment to providing opportunity for dancers in the community is worthy of a Legacy Games Grant. As a lead dance instructor at MacDonald Island Dance Academy, I have been working closely with the Team and the Association for years. In the past five seasons, the Association has continued to support dancers in ways that are unparalleled. Most recently, as part of their mandate, the Association has been allocating funds to provide dancers with opportunities to work with world-class choreographers and teachers locally.

In the past years, the Team has travelled to Edmonton to participate in workshops in addition to their competitions. This has been a truly beneficial experience for the dancers in that they have had a chance to work with many talented instructors and choreographers. This year the team had to reevaluate these trips, as it was becoming increasingly hard for team members to finance an additional weekend in Edmonton. With the help of the Association, the dancers are now getting to work with the world-class choreographers in Fort McMurray. A plan has been put into motion, in which choreographers will be brought into Fort McMurray, and the workshops will be held here. The byproduct of this fundraising support has been a visible improvement of the standard of dance throughout the Wood Buffalo region.
