4.3. Review of Water and Sanitary Utility Rate Differentials

Antoine Rempp, Director, Environmental Services, Laurie Farquharson, Chief Financial Officer and Chris Davis, Senior Manager, Legal Services, presented the Review of Water and Sanitary Utility Rates Differentials in response to Council's direction to determine if there are inequities in the current fee structure. It was noted that the recommendation from Administration is based on current engineering standard requirements, benchmarking, administrative feasibility, timeliness and cost impact.

Point of Order

During questions of Council Councillor A. Grandison called a Point of Order with respect to the questions posed by Councillor K. Cardinal noting that they are not relevant to the matter. The Point of Order was upheld by Mayor S. Bowman.
