3. Financial Services Division Proposed Transition and Work Plan

4. 2014 Provincial School Tax Increase

Brian Moore, Director, Assessment and Taxation, addressed Council regarding the 2014 Education Tax increase mandated by the Province of Alberta, and suggested that a similar communications plan be implemented to the one held in 2013.

A discussion ensued and it was suggested that a letter be send to the Province regarding the school tax increase. It was asked that an invitation be sent to the Minister of Education, MLA Don Scott and MLA Mike Allen requesting a meeting with the members of Council to discuss the school tax increase. It was recommended that the contact information for both local MLAs be included on the 2014 tax bills.

Moved by Councillor K. McGrath that:

- the Audit and Budget Committee recommend a letter from Council be sent to the Province regarding the education tax requisition increase;
- a meeting be scheduled with both local MLAs and the Minister of Education regarding the education tax requisition increase;
- a communications plan, similar to last year, be implemented to ensure the public is aware of the source of the increase on the 2014 tax bill; and
- the contact information for both local MLAs be included on the 2014 tax bills.
