Frank Creasey, Chair of the Taxi Advisory Committee (TAC), provided a brief overview of the function and role of the Taxi Advisory Committee.

#### **New and Unfinished Business**

3. Residential Street Safety and On-Street Parking Update (4:15 p.m. – 4:20 p.m.)

Dawny George, Director of Engineering, and Mazhar Hajhossein, Senior Transportation Engineer, provided a brief update of the residential street safety and on-street parking study which was on target to be presented to Council by the end of August, 2016 prior to the wildfire.

Ms. George indicated that an extension request will be going before Council to extend the completion of the project to the end of February 2017, provided they have restarted the project by September.

Jamie Doyle, Director of Planning and Development, provided a brief update of the progress of Edinburgh Tower, which has been rebranded as Rio Verde, and indicated that all updated drawings are to be submitted to the Planning and Development Department by August 25, 2016. Mr. Doyle also indicated that he will continue to update this Committee on the progression of this property.

#### 12. Speed Limit - Saprae Creek Trail (5:15 p.m. – 5:18 p.m.)

The following motion was put forward for consideration by Councillor A. Vinni: that this item be forwarded to Council for consideration and approval that the \$250,000.00 funding required to make the upgrades to increase the speed limit of the Saprae Creek Trail from 70 kilometers an hour to 80 kilometers per hour be approved.

> Moved by Councillor A. Vinni that it be recommended to Council that the \$250,000 required to upgrade the speed limit on Saprae Creek Trail from 70 km/hour to 80 km/hour between MacKenzie Boulevard and the Fort McMurray International Airport be approved.
