## 4. **Presentations**

## 4.1. Nicole Spring, Regional Inclusive Committee re: Collaboration with the Regional Advisory Committee

Christopher Whelan provided a presentation on behalf of the Regional Inclusive Committee (RIC), regarding current RIC initiatives and requested that the RIC and the Regional Advisory Committee on Inclusion, Diversity and Equality (RACIDE) collaborate on matters of accessibility. A discussion occurred about the possibility to add a member of RIC to the RACIDE Committee in the future.

Administration committed to conducting a review of RACIDE's mandate and membership in conjunction with the mandates of other Committees and Community Coalitions, such as RIC and the Advisory Committee on Aging, and report back to RACIDE in September with a holistic Committee vision.

## 5. New and Unfinished Business

## 5.1. Administrative Update - Human Resources

Kari Westhaver, Director, Human Resources provided an overview of the Regional Municipality of Wood Buffalo's administrative directives, policies, onboarding practices and collective agreements that speak to discrimination and racism in the workplace. She indicated that harassment and discrimination complaints are taken very seriously.

Through consensus of the Committee, it was determined that agenda item 5.5 – Anti Racism Group Update, would follow item 5.1 – Administrative Update – Human Resources.

## 5.5. Anti-Racism Working Group Update

Committee Member, Mitchel Bowers, provided an update on the Anti-Racism Working Group, noting that there were two Conversation Cafes held in July, with several more planned in the upcoming weeks.

It was indicated that feedback from the Conversation Cafes, suggest that the Regional Municipality of Wood Buffalo (RMWB) is a welcoming community; however, racism and discrimination in the workplace is prevalent even within the Municipality as an organization.

Administration provided clarity on the processes and procedures used by the Municipality to address racism and discrimination in the workplace and urged current and former employees of the Municipality to report any discriminatory incidents through established processes, including the Whistleblower Administrative Directive. It was also indicated by Administration that anonymous employee surveys and diversity census' are in the process of being developed to be released to RMWB employees. CAO Jamie Doyle indicated that he has an open-door policy and welcomes discussion with employees on these issues.

### 5.2. Awareness Campaigns

Administration spoke to the need to develop logo, branding, etc. for RACIDE in preparation for upcoming awareness campaigns. It was noted that at the next RACIDE Committee meeting, further discussion will occur surrounding this matter.

## 5.3. Strategic Plan Planning Session

Discussions on this item did not occur due to time constraints.

### 5.4. I See You: Sawubona Art Exhibit Social Media Plan

Chair, Jason Beck, indicated that the *I See You: Sawubona Art Exhibit* is currently on tour and suggested that it would be a great time to share the collection of video stories

that are included in the exhibit, with the public via social media. Administration indicated that they will contact each contributor to the video stories in to obtain additional consent to release their narratives on the website.

## 5.6. Benchmarking Update

Administration indicated that benchmarking research is ongoing, and discussions have taken place with other municipalities regarding their inclusivity and diversity departments. In addition, Chair, Jason Beck and Deanne Bergey, Director of Community Services, met with Alberta Health Services for a discussion on their diversity office.
