4. New and Unfinished Business

4.1. Downtown Area Redevelopment Plan Final Engagement

Entrance

Committee Member J. Ellis joined the meeting at 9:26 a.m.

Chris Booth, Manager, Planning and Development, presented the Downtown Area Redevelopment Plan highlighting that the project's purpose is to respond to the Downtown's changing social, economic and cultural conditions and to guide further development of the Downtown. An outline of the plan's structure, project progress and next steps were overviewed, where objectives of the plan were reviewed, and it was noted that this plan is in the final engagement phase and following public engagement, the feedback received will be reviewed and as the final document is considered a Statutory Plan, the document will go forward to Council for enaction.

Committee Members discussed the plan and provided feedback for consideration.

Vacating, Assuming and Resuming of Chair

Vice Chair Jennifer Vardy vacated the Chair at 10:33 a.m., at which time Committee Member Alex McKenzie assumed the Chair. Vice Chair Jennifer Vardy resumed the Chair at 10:37 a.m.

4.2. Downtown Revitalization Incentive Program Update

Chris Booth, Manager, Planning and Development, provided a brief update on the Downtown Revitalization Incentive Program that was introduced in June 2020 noting the program's success, with an overall 191 approved applications and \$7 million that's been committed based on the approved applications. It was further noted that the programs current phase has received 40 applications to date and will close in April 2023.

4.3. 2023 Committee Priorities Update

Vice Chair Jennifer Vardy provided an update on behalf of the Priorities Working Group, on the work that has been undertaken towards prioritizing and identifying the Committee's initiatives for 2023 and future years. Following discussions of the Committee it was agreed to bring this matter back for discussion at the next Committee meeting and include an overview of initiatives accomplished in 2022.

Committee members discussed the Committee's year-end report to Council and feedback was provided on the timelines associated with presenting to Council at an upcoming regular meeting.

4.4. Minister of Service Alberta and Red Tape Reduction Correspondence Update

Vice Chair Jennifer Vardy provided a brief overview of the correspondence that was received from the Minister of Service Alberta and Red Tape Reduction noting there is a new Minister of Red Tape Reduction and that the mandate has been reestablished.

With consensus of the Committee, a letter from the Chair will be sent to the new Minister of Service Alberta and Red Tape Reduction requesting quarterly meetings be scheduled.

4.5. Clean Energy Improvement Program

Committee Member Justin Ellis presented the Clean Energy Improvement Program (CEIP) that is administered by the Alberta Municipalities Association noting that this program is Alberta's innovative financing tool enabling residential and commercial property owners to pay for energy efficiency and renewable energy upgrades.

Committee Members agreed to form a working group that will complete a feasibility study on the CEIP and present the findings to the Committee for consideration as an initiative of the Committee.

Dear Mr. Kumka:

Thank you for your congratulatory note regarding my appointment as Minister of Service Alberta and Red Tape Reduction in Premier Danielle Smith's Cabinet. It is an honour and a privilege to serve the people of Alberta in this capacity.

I appreciate you sharing a copy of the Regional Municipality of Wood Buffalo's Planning and Development Department Process Review report. The report's focus on making building and development permits easier and faster to obtain by eliminating duplicative application requirements, creating a single application form for residential building permits, and ensuring permit application requirements are clear and easy to follow aligns with the Government of Alberta's commitment to cut red tape by one-third. Making life easier for hardworking Albertans and businesses is a goal we share.

As you may be aware, my Mandate Letter includes direction to reduce wait times for permit approvals across all ministries, and to report on the feasibility of implementing an 'automatic yes' approach that assumes permits are approved within a reasonable period of time unless a rationale is provided to support rejection. I have shared your report with my department staff for their consideration, as we continue to work towards implementing this mandate item.

Concurrently, Municipal Affairs is collecting benchmark data on the number and value of subdivision applications, development permit applications, and building permits issued for all 332 municipalities in Alberta. By summer 2023, this information will be included in the Municipal Measurement Index, an online dashboard that allows Albertans to evaluate the performance of their local government in comparison with other municipalities. This information will also be used to support Municipal Affairs' mandate to work with municipalities to benchmark, measure, and reduce the time it takes to approve permits to create a more attractive business environment for investment.

6) Issues background (a brief on the context and background of issues)

Throughout 2021, members of the WBDAC met with the former Associate Minister of Red Tape Reduction; Tanya Fir quarterly to better understand:

- 1. Red Tape Reduction work that has been completed and work that is underway by the Government of Alberta (GOA).
- 2. More about what Red Tape Reduction initiatives have been working within the provincial government and find out more about what other municipalities are doing and what's working.

Honorable Dally Nally's mandate includes direction to reduce wait times for permit approvals across all ministries and report on the feasibility of implementing an automatic yes approach for permit approvals. The WBDAC members have been provided a copy of the most current Red Tape Reduction Annual Report 2021-2022 which highlights progress to the end of 2022.

On March 1, 2023, the Chair of the Wood Buffalo Development Advisory Committee shared an overview of written correspondence from Honorable Dale Nally; Minister of Service Alberta and Red Tape Reduction inviting committee members to meet with him to discuss how we can continue to work together. Specifically, an interest in further exploring how we can work together to eliminate development and building permit red tape continues to be of interest in creating a more attractive business environment for investment.

The RMWB continues to work on making building permits and development permits easier and faster to obtain by eliminating duplicative application requirement, creating a single application form for residential building permits and ensuring permit application requirements are clear and easy to follow. Monitoring and measuring progress will be important next steps.

Perspectives of municipality and WBDAC

Municipality: Councils 2022-2025 Strategic Plan outlines Local Economy as a strategic area of focus. The intended outcome is to make this region a destination of choice for economic development and quality of life by supporting growth of the local business community and improve services to residents.

The WBDAC mandate and initiatives include but are not limited to:

- Local development initiatives support strategic planning and land use development (i.e., Municipal Development plan, Downtown Area Redevelopment Plan, Land Use Bylaw, Detailed Land Use Map for Downtown)
- Development, construction and community-based issues Planning and Development Process Review Report
- Public engagement activities (i.e., Rural Tourism Engagement)

•	Region-wide economic priorities - thankful for GOA investments that support industry (i.e., HWY improvements)
•	Incentivizing private Investment Investments Downtown (Downtown Revitalization Incentives Program)

Desired Outcomes

- Establish a positive relationship between the RMWB Administration, Wood Buffalo Development Advisory Committee members and the Government of Alberta for ongoing collaboration.
- Seek a shared understanding about how we can continue to work together to add value and advance red tape reduction initiatives that benefit the province and our region.
- Demonstrate our proactive interest in continuing to support red tape reduction and willingness to be a key point of contact for the GOA and regional champion for ongoing initiatives.
- Increase a shared understanding about what's already taken place or ongoing in terms of Red Tape Reduction.
