4.1. Vehicle for Hire Committee Identified Priorities

Following a fulsome discussion, the Committee identified the following as their priorities:

- Priority 1 Inspections and Enforcement
- Priority 2 Driver Training and Education
- Priority 3 Rules and Regulations
- Priority 4 Vehicle for Hire Statistics

Coming out of the prioritization exercise Committee members provided input on the various components to the identified priorities and discussed actionable elements contained within each priority topic. With consensus of the Committee an Inspections and Enforcement Working Group was struck consisting of Vice-Chair Michael Sieger and Committee Member Abdifatah Mursal, and a Driver Education and Training Working Group consisting of Chair Julieta Miranda and Committee Member Penny Skinner.

It was agreed that the two Working Groups would conduct research and identify any emerging trends impacting the vehicle for hire industry under Priority 1 and 2. The finding along with any benchmarking will be reported back to the Committee at the next regular Committee Meeting.
