## **Lease of Office Space – 9717 Franklin Avenue**

Mr. Steve Cook, Land Manager, was in attendance to provide an overview of the proposed lease and responded to questions from Council.

- 2. THAT the purchase of 9715 Main Street funded with \$2,000,000 from the Emerging Issues Reserve and \$2,000,000 from the Asset Addition Reserve be cancelled;
- 3. THAT \$1,500,000 be approved from the Emerging Issues Reserve for the cost of rent, renovations and furniture at 9717 Franklin Avenue; and
- 4. THAT \$500,000 be approved from the Emerging Issues Reserve for upcoming renovations in other office leases anticipated in 2007.

It was clarified that the building will house approximately 56-70 people, and will be ready for occupancy within 90-120 days of being vacated, which is expected to happen in mid-April. It was also noted that funds have been included in the 2008 financial plan for the commissioning of a study of the development of a civic centre in the lower townsite to address the Municipality's long-term needs.

A lengthy discussion ensued with respect to stop-gap measures being utilized and the value being provided to taxpayers as a result. Concern was expressed about the establishment of satellite offices and the difficulties associated with supporting and managing operations, as well as communicating between various departments. It was also noted that building a civic centre will require detailed planning and will take several years. In the interim, it is necessary to secure other space to house municipal operations.

# Title Partnership – MacDonald Island Park Redevelopment Project

## Resolution # 07-035

MOVED by Deputy Mayor Meagher:

- 1. THAT Articles 02.03 (d), 03.06 (d) and 03.07 of the Community Identification System Policy 040-2006 be waived.
- 2. THAT the Municipality be authorized to enter into the agreement policy with Suncor Energy Foundation, dated February 2007, for external naming rights of MacDonald Island Park Recreation Complex for \$3,000,000.00.

Concern was expressed relative to the transparency and fairness of the process and the fact that Council is essentially revoking the policy adopted in 2006 to facilitate the title partnership. Concern was also expressed about the retention of the current C.A. Knight name, as former Mayor Chuck Knight was instrumental in retaining MacDonald Island as a recreational centre.

It was noted that this should be viewed as a contractual arrangement whereby a company receives marketing and advertising benefits from having its name attached to one of the largest recreation facilities in the province, subject to providing appropriate compensation to municipal ratepayers. It was noted that the Municipality has not tested the market to determine what businesses are willing to pay for the right to put their company name on the facility and that the Municipality has missed an opportunity to raise extra revenue to offset the cost to taxpayers.

The Regional Manager then provided an overview of the negotiations that have taken place, beginning in 2005. He noted that the Municipality had retained Ketchum Consulting to assess potential sponsorships, and they had established an amount of \$2 Million for a 20 year period. Through the negotiation process, Suncor increased its contribution to \$3 Million for 10 years. He noted that, in comparison with other facilities in Western Canada, this is the largest amount offered for facility naming rates. In addition, Suncor has agreed to sit on the fundraising committee, which is very advantageous for the Municipality and will likely net larger contributions in the long run. Mr. Newell indicated that Administration believes both the amount and term of the agreement to be fair and of benefit to the Municipality in the long run.

Several Councillors spoke of Suncor's commitment to the community, both as a corporate citizen and supporter of sporting and the arts, and that the Municipality is very fortunate to have the company sponsoring the project. In addition, several Council Members expressed their belief that Suncor is committed to ensuring the development of a world class facility and will extend their support beyond the terms of the existing agreement.
