Ms. Beth Anthony, Executive Director, Justin Slade Youth Foundation re: Update on Dugout

The dugout recently celebrated its one year anniversary. The past year have seen 4200 kids utilize the services available, as a result they have been able to develop new programs and activities. This summer they are hoping to run programs five days a week. The dugout has developed partnerships with the University of Alberta, Youth Justice Committee and the HIV Society (Positive Space Campaign). The dugout has also brought the life skills program into Father Mercredi high school and Second Chance high school. In addition to all of this the dugout has also now started to offer free meeting space to non profit organizations in the community. They are also looking at opening a second and possibly a third dugout location. The dugout has also seen the need to have more outreach workers to assist with the growing demand. The dugout will also be moving to the airways through the new radio station KAOS 99.1 to promote their services. Lastly, they are also hosting the second annual golf tournament this year.

There was a brief discussion by council and they commended the Slade family for turning a tragic loss into an excellent program that benefits many young residents.

She stated that there are no incentives to doing business in rural settings. She suggested the possibility of council creating a rebate program for small businesses in rural settings.

Mr. Dave Marshall, resident, re: Forcemain from Lift Station 1B to Wastewater Treatment Facility, expressed his desire that council not support a two million dollar sewer line but does support the upgrading of pump 1A. Mr. Marshall feels that Council should not service property that is owned by the province, that we should buy the land first and then service it.
