Call to Order

Mayor Blake called the meeting to order at 6:01p.m.

Opening Prayer

The Mayor asked everyone to join her in Prayer.

2. Jennifer Dahl re: Street Maintenance Notification

She put forward the request that Council consider increasing neighbourhood notification time frame for vehicle removal to one week prior to doing street maintenance. She further suggested the municipality consider alternate methods of communicating with the residents about upcoming street maintenance.

- b) All existing caveats registered on the title will need to be carried forward onto the newly created titles;
- c) The developer shall enter into a development agreement with the Regional Municipality of Wood Buffalo in a form suitable to the Municipality for the construction of municipal infrastructure that may include, but not be limited to, the construction of roads and underground services;
- d) If it should be necessary as a result of this subdivision to install, lower, alter or relocate any municipal or franchise utilities, such modification shall be to the standard of the Municipality or franchise utility and all cost shall be borne by the developer;
- e) No development will be allowed on site until such time as Engineering Services has approved the access to the site; and
- f) A covenant that restricts on-street parking shall be registered on

the following lots:

- Phase 3C Lots 13-24 inclusive, Block 15
- Phase 4B Lots 36-40 inclusive, Block 15
 CARRIED UNANIMOUSLY
