Minimization of Plastic Bags

Resolution # 07-268

MOVED by Councillor Vyboh that the administrative report, dated June 26, 2007, be accepted as information.

The Superintendent, Infrastructure Division advised that approximately 50 million plastic bags are disposed of at the regional landfill site annually. The Solid Waste Master Plan will not deal directly with this issue, but will offer guiding information and direction as to the most effective means of dealing with plastics and plastic waste. Mr. Elder also noted that the success of any program to eliminate or reduce the use of plastic bags is contingent on the consumer buying into the program, as well as retailers.

School Zone Traffic Control

Resolution # 07-269

MOVED by Councillor Clarkson that the Transportation Association of Canada (TAC) Standards be followed until the University of Calgary report is presented to Council.

It was noted that Council had previously enacted school zone time changes to accurately reflect what's happening for students in the community. Several Councillors have been contacted by one school in particular that has been quite vocal about what they see as a dangerous situation in the community. It was questioned as to whether the TAC standards are minimum guidelines to follow, or if the Municipality should be doing something more. It was also noted that the Municipality has established a precedent by installing rumble strips in front of the Fort McMurray Composite High School several years ago.

The Superintendent of Infrastructure advised that the report from the University of Calgary would likely be completed by the end of December 2007. Safety is based upon a "triple E" approach, meaning engineering, education and enforcement. Mr. Elder indicated that administration is fully aware of the traffic problems and has had discussions with school administration and parent councils. He noted that, in some instances, approximately 90% of the traffic is generated from within the school itself, therefore, education plays a very important role in the process.

The Chief Administrative Officer noted that the TAC standards are based on a body of knowledge developed over time. If the Municipality chooses not to adhere to the TAC standards, then an independent study is needed to support that action, regardless of whether the lesser or more stringent standard is applied. The

University of Calgary study will assist in the Municipality in determining what, if any, action is warranted, and is a requirement if administration is to make recommendations to Council. It was noted that there would be some incidental costs incurred for the study, but would not be as high as if a full-blown engineering study was undertaken.

Parcel F Subdivision (Stone Creek)

Resolution # 07-270

- 1. Any and all easements required by the Municipality or any franchise utility as a result of this development shall be provided by the developer at no cost to the Municipality or any franchise utility and shall be registered on title by Utility Right-of-Way Plan;
- 2. All existing caveats registered on the title will need to be carried forward onto the newly created titles;
- 3. The Developer shall enter into a development agreement with the Regional Municipality of Wood Buffalo in a form suitable to the Municipality for the construction of Municipal Infrastructure that may include but not limited to the construction of roads and underground services;
- 4. If it should be necessary, as a result of this subdivision, to install, lower, alter or relocate any Municipal or franchise utilities such modification shall be to the standard of the Municipality or franchise utility and all cost shall be borne by the Developer; and
- 5. A Restrictive Covenant restricting on street parking shall be registered Lot 2, Block 7.

In response to questions, Mr. Ed Salmon, Manager of Land Services, advised that the proposed subdivision does meet infrastructure

guidelines, however, the area, once fully developed, will fill the capacity for that area. Mr. Salmon explained that once Parcel "F" is completed, there will be a need for new or expanded infrastructure to service any further development.
