  - b) Confirmation that the development concept can support a transportation link from Thickwood/Timberlea to the west;
  - c) Approval of an amendment to the Municipal Development Plan to adjust the Urban Service Area boundary;
  - d) Approval of an amendment to the Real Martin West Area Structure Plan to accommodate expansion of institutional land uses.
- 2. THAT Administration begin the process to evaluate the site for the purposes of a recreation complex and begin discussions with the Government of Alberta to acquire land for a recreation complex in the Real Martin West area.

October 10<sup>th</sup>. All parties have an interest in expediting the process; however, a common understanding is needed of how the groups will work together and the lands west of the subject property needs to be assessed as there are some development challenges associated with it. The Municipality also has an interest in establishing a specific site for a recreational facility. Although there are no definite dates available, all organizations are experiencing stresses and have a definite interest in moving ahead quickly. In addition, each stakeholder also has to allocate funds, and determine how much land is needed so that a site design can be prepared.
