Project Description and Scope

The Ministry of Justice and Solicitor General invested over \$350 million in building and deploying across Alberta a two-way radio communications network known as the Alberta First Responders Radio Communications System, AFRRCS, to be used at no charge by first responders, i.e. Fire, EMS, 911, Bylaw Services, and RCMP, across the Province. The CAO signed a contractual Access Agreement with AFRRCS that allows first responders of the RMWB to make use of AFRRCS at no charge until 2030. Bylaw Services has been using for many years the RCMP's radio communications platform to meet their radio communication needs, however, the RCMP has informed that they will be migrating to AFRRCS by Q3 of 2018. The Regional Emergency Services has also announced their plan to migrate to AFRRCS by Q2 of 2018. Bylaw Services needs to collaborate and work closely with the RCMP and the RES. Migrating to AFRRCS is in line with KPMG's Lessons Learned | 2016 Horse River Wildfire Report Recommendations and addresses the current radio communications issues highlighted in the report's findings and recommendations. Not executing the project will leave Bylaw Services without a radio communication tool affecting their dispatch staff and operations and safety of its officers. It will also hinder its capacity to effectively collaborate with the RES and the RCMP during emergency response situations, during special operations, and to support their activities.
