

- Council's responsibilities as set out in the *Municipal Government Act*, include:
  - Considering the welfare and interests of the Municipality as a whole
  - Participating in developing and evaluating policies and programs
  - Participating in Council and Committee meetings
  - Obtaining information about operations from the CAO or designate
  - Maintaining confidentiality
  - Adhering to the Code of Conduct established by Council

### Executive Offices - Highlights

- Increase in Salaries, Wages and Benefit expenditures due to two new positions: Director of Strategic Planning and Business Initiatives; and, Senior Strategic Advisor.
- Net increase of \$50,130 in Contracted and General Services is related to the engagement of advocacy services on behalf of the Municipality to influence public policy and decision-making concerning our region.
- Decrease in vehicle rental of \$14,400 due to vehicle allowance now being a part of the CAO's compensation package

# **Legislative Services**

### Legislative Services

Programs and Services at a Glance

- The Department is comprised of two branches, Legislative Services and Corporate Records.
- Legislative Services preserves the integrity of the democratic process by managing and administering legislative functions as set out in the *Municipal Government Act* (MGA) and the *Local Authorities Elections Act* (LAEA) with impartiality, integrity and professionalism.
- The Legislative Services Branch is responsible for Legislative meeting support to Council and all Council appointed Boards & Committees, management of the legislated tribunals, as well as overall management of Municipal Elections and By-Elections.

### Legislative Services

Programs and Services at a Glance

- Corporate Records provides accountability to internal stakeholders through access to information and ensuring the integrity of corporate records are upheld.
- The Corporate Records Branch is responsible for providing expert records management advice to municipal departments, managing records throughout their lifecycle, and preserving corporate memory.

### Legislative Services - Highlights

 Increase in salaries to accommodate new positions in Legislative Services Branch including Manager, Legislative Coordinator and temporary Elections Assistant. This has been offset by not filling two Legislative Officer positions for 2021.

2021 Municipal Election Expenses (including referendum & Senate):

- Increase in printing and binding of \$92,000 directly related to ballots, special ballots, voting registers for the 2021 Municipal General Election.
- Increase in general services contracted of \$207,000 for the lease of voting machines and election worker remuneration specific to the 2021 Municipal General Election.

### Legislative Services - Highlights

2021 Municipal Election Expenses:

- Increase in room rental costs of \$41,400 in the event schools are not available for use as voting stations.
- Increase in office supplies of \$32,050 attributed to voting stations.
