Dear Honourable Mayor and Council

My name is Kedra Abdurahman, I am an Early Childhood Diploma graduate from Keyano who has spent the last 6 years working for a non-profit daycare within the Fort McMurray community. I am the mother of two little girls ages 8 and 6. I recently went through a separation and I'm now considered to be a single mom.

When I chose to become an early childhood educator I already knew there was no money to be made in the field however what I was passionate about was finding ways to learn and understand children as a whole.

Even though I knew there wasn't any money in this field it didn't stop me from pursuing an education in the field and becoming a passionate educator.

Now that I somehow fast forwarded 6 years of my life dedicated to this field, I'm forced to leave due to financial burdens. With a heavy heart, I officially gave my formal resignation letter yesterday.

In April of this year I suffered serious financial burdens as the \$1040 NLA pay I receive every month was taken away from me followed by an hourly pay cut that took effect two weeks later. My employer explained to me that my hourly pay cut was due to the Pandemic and of the cuts to the ELCC grant. On top of the NLA loss, pay decrease and a 300% fee increase to my childs daycare fee all taking place in the same month, I struggled to keep a positive mind set. These changes lead me into severe depression. I never imagined the day would come where I had to choose between doing something I'm passionate about or having a job with more financial stability. There were moments I contemplated leaving town because it no longer made financial sense to remain in Fort McMurray; however I did not want to separate my children from their father.

Today I am not only asking you but I am begging the mayor and council to advocate for the province to except the \$10 a day plan and I'm also begging you to find a way advocate to better support childcare workers with a wage that allows them to live without needing a second job or having to leave the field. My final request is that the Mayor and council also find a way to advocate so that the early childhood field can be recognized as a profession and workers are treated as such.
