Subject: 2016-2017 Organizational Meeting

Administrative Recommendations:

- 1. THAT the proposed 2016-2017 Council Representation on Boards and Committees, as outlined in Attachment 1, for the period October 12, 2016 until the date of the 2017 municipal election, be approved.
- 2. THAT the proposed Deputy and Acting Mayor Assignments, as outlined in Attachment 2, for the period November 1, 2016 to the date of the 2017 municipal election, be approved.
- 3. THAT regular Council meetings be held in the Jubilee Centre Council Chamber weekly on Tuesdays at 6:00 p.m., excluding fifth Tuesdays, statutory holidays and any scheduled recess periods; and
 - THAT 2017 Community Engagement Initiatives be held in Fort Chipewyan, Fort McKay and Saprae Creek, with the date and format of the event to be determined in consultation with community leaders.
- 4. THAT the seating assignments for Councillors, as outlined in Attachment 3, for the period October 12, 2016 until the date of the 2017 municipal election, be approved.

Summary and Background:

Both the *Municipal Government Act* and the Municipality's Procedure Bylaw require that Council hold an annual organizational meeting within two weeks of the third Monday in October to address the following matters:

- Establishment of a Deputy and Acting Mayor Roster
- Establishment of a Schedule of Council Meetings
- Council Chamber Seating Assignments
