It was requested that Administration obtain a permit from the Department of Fisheries and Oceans for dredging of the Snye should water levels not be sufficient to host events. It was also requested that a mixed material be placed at the Willow Lake Day Use area in Anzac to hold the weight of the vehicles due to the soft ground in that area.
