- Highway 686 provides access to Parsons Creek Subdivision from Highway 63








- Highway 63 and 686 will be access controlled via interchanges only

Summary:

General Manager

The Community Identification Committee (CIC) met recently and has recommended a number of names for municipal roadways. In accordance with the Community Identification System Council Policy (No. PRL-040-2006), approval from Council is required for all roadway naming.

Background:

On October 13, 2009, the naming of the road being constructed through the Lower Townsite was brought forward to Council. The Community Identification Committee had recommended to Council that the road be named "The Prairie Loop Drive"; however, it was moved that the matter be referred back to the Community Identification Committee for further review and recommendation.

While Council had discussed other potential names for the Lower Townsite road, no specific direction was given that the Committee consider those names. The CIC, therefore, developed the above presented list of potential names in order to provide Council with choices for the naming of the Lower Townsite road.

On October 28, 2009, the CIC met (Attachment 1) to make recommendations to Council for the naming of the following roadways:

Proposed Names:

1) Naming of the road in the Lower Townsite

The Community Identification Committee has recommended the following names for the road in the Lower Townsite:

Dunvegan Drive was proposed to demonstrate the historical significance of railway in Fort McMurray and to recognize Edmonton, Dunvegan & B.C. Railway, which was an early pioneer railway in northwestern Alberta.

Furber Freeway was proposed in honor of the Furber family, particularly Tim and Gerry Furber, who are long term residents in Fort McMurray and have contributed to the local community development in Waterways in the 1950s.

Steamboat Boulevard was proposed to recognize the historical significance of steamboats to Northern Alberta fur industries and Fort McMurray's economic development.

Marine Drive was proposed to recognize the geographic characteristics in the Lower Townsite District.

N.T. (Northern Transportation) **Landing Drive** was proposed to recognize the historical significance of marine transportation services in the 1940s.

Grahame Drive was proposed to recognize the importance of Hudson's Bay Company stern wheel steamer, which marked the history of marine transportation in the 1800s.


Nistawoyou Road was named after the Alberta Native Friendship Center branch in Fort McMurray. The name was proposed to enhance the relationship between Aboriginal and non-Aboriginal citizens.

2) Naming of roadway at MacDonald Island


