

# 4.6. Franklin and Main Park

### <u>Update</u>

Rick Gendron, 818 Studio, Bipul Bhowmik, Transportation Engineer, Engineering, and, Monica Lance, Manager, Special Projects, presented an update on the Franklin and Main Park Project, including the proposed winter concept design.

Naming the Park Process Overview

Such Chandhiok, Supervisor, Statutory Plans, Planning and Development, provided an overview of the naming process for streets, parks and other Municipal facilities, noting that applications for naming the park would go to the Community Identification Committee, which would make the recommendation to Council for final approval.

Roy Williams, Chair, provided an update on the presentation of the Committee's Annual Progress Report to Council on November 10, 2020, which highlighted the Committee's 2020 achievements and the priorities and recommended actions for 2021 including beautification, placemaking, neighborhood safety and pedestrian friendliness in the downtown.

It was noted that Council accepted the Committee's 2021 Priorities and Recommended Infrastructure and Enhancement Actions, and directed Administration to implement the recommended actions and priorities with any required funding to come from the approved unallocated Downtown Revitalization Capital Project budget.

# 4.8. Working Group Roles and Responsibilities

Chair Roy Williams and Monica Lance, Manager, Special Projects, led the overview of the roles and responsibilities of the two Working Groups: Group 1 - Beautification and Placemaking; and Group 2 - Neighbourhood Safety and Pedestrian Friendliness. It was noted that the purpose of the Working Groups is to provide advice and initiate action towards the Committee's approved 2020/2021 priorities and recommended infrastructure enhancement actions, and to address identified Committee initiatives as outlined within the Committees Bylaw.






# What is the MDP?

The MDP sets out the vision and blueprint for how growth and development will happen in Wood Buffalo over the next 20 years.


# The MDP will:


- » Provide a comprehensive land use policy framework
- Outline a strategic path forward to manage growth across the Region
- » Guide both short- and long-term decision making by Council and Administration
- » Decisions will shape the development and future changes made to your communities



# Why is it important?

- » The 2011 MDP growth projections indicated that Wood Buffalo's population would grow to over 230,000 people by 2030
- » This growth has not happened due to several factors, including the 2013 floods, the 2014 global drop in oil prices and resulting economic downturn, the 2016 Horse River Wildfire, and the 2020 floods
- In response to changing social and economic environments, the Municipality has taken this opportunity to reflect today's conditions through a new MDP





### Focus On People & Community

- At the heart of all our communities are the people
- » Focus on the people and communities of Wood Buffalo first by:
  - Ensuring residents have access to their daily needs within accessible, safe environments,
  - Provide social, cultural, recreational, and employment opportunities that support healthy and fulfilling lives
  - » Enhance high quality of life



### Establish Green & Blue Networks

### » Green Network:

- » Connects natural open spaces and trails across the Region
- Increase recreation and mobility options, enhance open space, and improve access to natural areas in a sustainable manner
- » Blue Network:
  - » Enhance waterfront and river recreation opportunities
  - » Improve flood protection

  - Balance the need to preserve sensitive landscapes with the desire to access nature




### Leverage Existing Assets & Expertise

### Simplify the Transportation Network

- » Reflect Wood Buffalo's current transportation needs:
  - » Simplify and right-size the transportation network

  - » Provide more options for mobility throughout the Region




### Foster the Lower Townsite as the Heart of the Region

- » Fort McMurray is the economic centre of Wood Buffalo
- The Lower Townsite acts as the heart of Fort McMurray, and the Region
  - Follow the guidance of the 2021
     Downtown Area Redevelopment
     Plan
  - Emphasize connections to MacDonald Island
  - » Grow into an exciting arts, entertainment, and cultural district



### **Evidence Based Approach to Work** Camps

- Proposes a "distance-traveled" **>>** approach to calculating the "reasonable commute distance" to restrict the use of work camp accommodations for fulltime employees of industrial operations in proximity to Fort McMurray
- The distance-traveled approach **>>** calculates the actual distance a vehicle travels using accessible and existing roads, determining a more realistic and accurate reasonable commute distance calculation for employees
- Opposed to the radius approach **>>** currently used



### Increase Arts & Cultural Representation & Collaboration

- Wood Buffalo has a multicultural identity is rooted in rich First Nations and Métis heritages
- » The 2018 census recorded significant ethnic diversity
- » Quality of life for all is enhanced through opportunities to celebrate the unique cultures of the Region
- Promotion of and participation in diverse arts and cultural activities provide educational opportunities and brings people together
- Increased collaboration with local communities will provide opportunities for people to make their voices heard, express their ideas, and tell their stories




### No Additional Growth Areas

- » In 2011, projections indicated that Wood Buffalo's population would reach over 230,000 people by 2030
- New sets of population projections, conducted in 2020, show that the Region's population will remain largely stable for the next 20 years
- » 2021 MDP will not allow the development of additional growth areas until existing areas are built
  - » Focus efforts and investments on existing communities
  - Allow the prioritization of enhancing the amenities, sense of place, and communities that already exist




### **Emphasize Rural Communities**

- » Wood Buffalo is one of the largest municipalities in Canada
- » Due to its size, the MDP incorporates guidance for both urban and rural communities, as well as for the Region as a whole
- Through increased collaboration with rural communities, the MDP will emphasize their unique needs and importance within the Region




