# 4.1. Such Chandhiok, Planning and Development, re: Municipal Development Plan Phase II Engagement

Such Chandhiok, Planning and Development, joined by Nicholas Khul and Pamela Downey, O2 Consulting Group, provided an update with respect to the Municipal Development Plan and sought feedback from the Committee on the draft vision and goals.

### 5. New and Unfinished Business

## 5.1. Review Naming Suggestions for the Franklin and Main Park

Monica Lance, Manager, Special Projects, provided an update noting that the naming suggestions being discussed by the Committee will be provided to the Community Identification Committee for consideration. Discussion included variations of names that would bring people together, such as the Cree word "Kiyām" meaning "you're at peace with yourself and your surroundings, and nothing anyone does or says can or will affect you or no negativity or malice will touch you".

#### Action Item:

Administration will summarize the Committee's feedback and prepare a report for the Community Identification Committee's consideration.

## 5.2. Canadian Heritage Legacy Grant Update

Bober Raja, Financial Services, provided an overview of the Canadian Heritage Legacy Grant and the various requirements to access the Grant.

#### Action Item:

The Committee requested an overview from Administration of any grants that could be applied for based on the initiatives being undertaken by the Committee and its Working Groups.

## 5.3. Working Group Updates and Ideas

Owen Erskine, Committee Member, provided an update from Group 1 – Beautification and Placemaking noting that various items were discussed during their meeting like flower displays, historical banners, areas for rock and bolder designs along Franklin Avenue; placement of "Welcome to Downtown" signage, and the possibility of working with building owners to create murals in the downtown area.

Jean-Marc Guillamot, Committee Member, provided an update from Working Group 2 – Neighbourhood Safety and Pedestrian Friendliness noting that their focus was on pedestrian walks, neighborhood safety and lighting within the downtown core area. It was also indicated that this working group discussed complimenting the initiatives undertaken by the Wood Buffalo Waterfront Advisory Committee.

Amanda Haitas, Planning and Development provided an update on the Downtown Revitalization Incentive Program noting that at present there are 50 approved applications equating to over \$4M investment in the downtown community. Discussion occurred with respect to Phase 2 of the Program which is anticipated to be brought forward to Council in March 2021.

Through consensus of the Committee, a letter of support from the Committee will be provided to Council to support Phase 2 of the Program.
