# 4.1. Red Tape Reduction Working Group Update

Chair Bryce Kumka noted that the Red Tape Reduction Working Group would be meeting during the week of October 2, 2023.

# 4.2. Land Use Bylaw Progress Update

Lee-Anne Kumka, Supervisor, Planning and Development, provided an overview of the current Land Use Bylaw (LUB), noting that the public engagement and drafting phases have occurred. It was noted that the LUB was presented to Council in 2021, which was defeated with the direction to work on a signage bylaw, Quarry Ridge land, Draper Road, and to collaborate with Fort McMurray First Nation. It was further noted that amendments related to each request have been brought forward to Council and will continue to be presented until the finalized version of the bylaw is complete and approved.

# 4.3. Municipal Development Progress Update

Kodjo Efu, Supervisor, Planning and Development, provided an update on the progress of the Municipal Development Plan (the Plan) noting that the Plan is in final stages, and will be complete once the final section related to demographics and population projections is complete and included.

# 4.4. Invest Alberta Recap

Chair Bryce Kumka provided an update on Invest Alberta, noting that there are 11 Invest Alberta branches globally that all work towards investment improvements in Alberta.

The Committee discussed how the various committee working groups can collaborate on how resources can be developed and utilized to aid in their own work towards improving investments in the region.

# 4.5. Committee Membership

Vice-Chair Jennifer Vardy spoke to the committee's current membership, noting that the Committee would benefit from the addition of an Indigenous Representative and a Rural Representative. The Committee briefly reviewed the current membership sectors and discussed how various sectors can be combined, and the potential to add or remove sectors to better align with the committee's mandate.
