4. New and Unfinished Business

4.1. Vehicle for Hire Statistics

Aaron Anderson, Manager, Bylaw Services, provided an overview of Vehicle for Hire Statistics, including incident types and dispositions for the reporting period of July 1, 2023, to November 15, 2023.

4.2. Inspections and Enforcement

Chair Julieta Miranda provided a review of inspection and enforcement benchmarking that was completed with the city of Grande Prairie, noting that they use a sticker/badge system which indicates that a vehicle for hire has been inspected and approved for operation.

The Committee discussed various options and variations for a sticker/badge system that could be incorporated into the vehicle for hire industry in the region.

With consensus of the Committee, the Inspections and Enforcement working group was renamed Inspections and Legislation working group, and Committee Member Rene Wells will join the working group.

Action Item

Administration to research options for a sticker program, including design parameters and costs, and present the information back to the committee.

4.3. Administrative Update

Aaron Anderson, Manager, Bylaw Services, provided administrative updates on the enforcement of cameras in shuttles, and public education on reporting vehicle for hire infractions or concerns.

Committee Members discussed the importance of cameras and surveillance in vehicles for hire, for the protection of drivers and passengers.

Action Item

Administration to provide benchmarking with other communities on their process for cameras and surveillance in shuttle vehicles.

4.4. Emerging Issues

Committee Members discussed the lack of clear legislation related to courtesy and shuttle services in the region.

Committee Member Rene Wells suggested that the committee consider developing a citizen satisfaction survey for vehicle for hire in the region.

Administration to provide the previous bylaw or provisions related to courtesy vehicles and shuttle services.




