Kyle Harrietha, General Manager, Fort McMurray Métis Local 1935, spoke in support of the proposed bylaw, indicating that this is the long-time home of the Métis and is of critical importance to the ongoing sustainability of their operations. Mr. Harrietha indicated that any future development on this site could have a serious and negative impact on the Métis Community of Fort McMurray and requested that they be consulted with in advance of any possible changes to the future use of the site.

Discussions ensued with respect to the rezoning and it was noted by Mr. Nalavde that this will not affect the special events that are held by the Métis Local on the current land. He further noted that the Government of Alberta has confirmed there are no other changes or new buildings planned for this site.
