- THAT the Mayor be directed to send a letter to the Premier and the Minister of Municipal Affairs, requesting that the Government of Alberta enact legislation to take effect before the next municipal election, prohibiting corporations and labour unions from making donations to the campaigns of persons running for the office of councillor or chief elected official under the Municipal Government Act; and
- 3. THAT the Regional Municipality submit resolutions to the Alberta Urban Municipalities Association and the Alberta Association of Municipal Districts and Counties, urging the Government of Alberta to pass legislation to take effect before the next municipal elections, prohibiting corporations and labour unions from making donations to the campaigns of persons running for the office of councillor or chief elected official under the *Municipal Government Act*."

Following debate, it was requested that the three provisions of the motion be voted upon separately.

Ault that the Regional Municipality of Wood Buffalo supports the proposition that both corporations and labour unions should be prohibited from making donations to the campaigns of persons running for the office of councillor or chief elected official under the Municipal Government Act;
