Councillor Slade indicated that she will be discussing this matter further with Council in the future.

Mr. Clarke confirmed that the value of land sold to the Municipality is typically established through a property appraisal. In this instance, the market value of the land was established and sold to the Municipality, which then sold the land at market value, plus administration costs.

Mr. Clarke clarified that R3-medium density zoning would allow development density of 145 units per hectare, whereas the proposed R2-1 district would allow a maximum density of 45 units per hectare. The R2-1 zoning better reflects the development capacity of Timberlea and would provide a better relationship between multi-family sites and single family sites. Mr. Clarke indicated that the R2-1 zoning is not being applied to any specific area at this time, but will give Administration more tools to work with in terms of future developments. Mr. Clarke also indicated that the Engineering Standards recently adopted by Council are reflective of those through Alberta, and are sufficient to ensure adequate land widths for purposes of parking and snow removal.
