4.2. Snow Clearing Policy Update

Dushan Baker, Program Manager, Roads, provided an update on the Urban Snow and Ice Control Policy, noting that the policy establishes the winter snow and ice control standards for urban roads and sidewalks. A review of policy changes, which expand on general procedures including priority schedules, service standards, maintenance triggers, back alleys, communication, and hazards, was provided.

4.3. Downtown Opportunity Assessment Project

Kevin Weidlich, President and CEO, Fort McMurray Wood Buffalo Economic Development and Tourism, provided an overview of the Downtown Opportunity Assessment Project (project), noting that the project will align with Councils strategic priority of downtown visualization. It was further noted that the goal is to increase development investment in the downtown core, increasing traffic to businesses.

4.4. Downtown Revitalization Incentives Program Engagement

4.5. Heritage Resource Management Plan

Isela Contreras- Dogbe, Supervisor, Community Services, presented the Heritage Resource Management Plan (Plan), noting that the Plan will help ensure the future of the Municipality's Heritage places, as identified in the Wood Buffalo Culture Plan. It was noted that a Heritage Inventory has been created to record various locations and buildings that are suggested to receive the Heritage Designation, as set out by *Alberta's Historical Resources Act*.

It was further noted that next steps include designating the first Municipal Historic Resource in Wood Buffalo, proposing designation of the Snye as a cultural landscape, and working with the Indigenous and Rural Relations Department to engage with Indigenous communities on further evaluation.

4.6. Saunderson Pressure Reducing Valve Project Update

Mason Ross, Manager, Engineering Programs, provided an update on the Saunderson Pressure Reducing Valve Project, including project objectives, 2023 completed work areas, and 2024 scheduled work areas, as well as the downtown revitalization components that have been included in the scope of work.
