The strategic plan of the Fort McKay Recreation & Cultural Society is ongoing. (see below)

### Provide a brief overview of the organization's strategic priorities:

The community of Fort McKay has undergone tremendous change over the last few years and continues to do so.

A number of facilities have been recently constructed including an arena in 2011 and a youth centre in 2016. A long term care facility will open in late 2017 and there plans to begin building a new community school in 2018. These facilities have allowed for the expansion of programmes in he community.

The Fort McKay Recreation & Cultural Society continues to work in cooperation with existing service providers in the community such as Fort McKay Wellness Centre, MOM's Daycare, Fort McKay Elders Centre, and Fort McKay Metis Assoc. in order to assist community members in making healthy lifestyle choices, supporting education through efforts to keep kids in school, dealing with social issues and enhancing the beauty of the community.

The Fort McKay Recreation & Cultural Society stays in contact with the Fort McKay Sustainability Dept. to determine the needs in the community.

### List the overall programs, services and events the organization provides:

The Fort McKay Recreation and Cultural Society provides a variety of recreational, leisure, and cultural programmes, activities, and events for all ages in the community. A number of these programmes are operated in cooperation with other community agencies and make use of the facilities operated by these groups, eg., pottery equipment, Fort McKay arena. As well as facilities throughout the RMWB such as the Vista Ridge Ski Area are utilized.

Programmes and services include:

- -graveyard maintenance
- -community cleanup
- -leadership training
- -youth programming (age 0-18) including sports, clinics, instruction, transportation, materials, speakers, recreational and cultural events, speakers, etc.
- -adult sport and leisure programmes
- -elders programming including transportation to the Lac Ste. Anne pilgrimage
- -special events

## Describe the elements, activities, or events of general operations that the organization is seeking this funding for:

The Fort McKay Recreation & Cultural Society endeavours to provide services and activities that encourage a healthy lifestyle for all members of the community of Fort McKay. While the emphasis is on programming for youth ((age 0-18) programming and activities are provided for all segments of the population. Recreational, leisure, and cultural programming is provided and speakers are brought in from outside the community to encourage a healthy lifestyle and enhance leadership skills.

While most programming takes place in Fort McKay, transportation is provided to venues in other areas of Wood Buffalo in order to take advantage of facilities such as Vista Ridge that are not available in the smaller community.

Services such as the maintenance of the graveyard and the community cleanup benefit the population as a whole as do special events.

## Explain how the operations/programming will achieve the objectives of the Municipal Strategic Plan as indicated on page 4:

The Fort McKay Recreation and Cultural Society will encourage the use of the recreational, leisure, and sports facilities in the community of Fort McKay including the Fort McKay Arena, Fort McKay School gymnasium, Fort McKay Elders Centre, Fort McKay Youth Centre, as well as playing fields, playgrounds, and green spaces.

The Fort Mckay Recreation and Cultural Society Provides will provide oppourtunities for all segnents of the community to access recreational and leisure facililities in the region by encouraging participation at venues such as the Vista Ridge Ski Hill, cross country ski trails, MacDonald Island aquatic centre, Gregoire Lake, etc. When necessary, transportation to these venues will be arranged.

In turn, groups from the larger community and outlying regions of Wood Buffalo are able to access the facilities available in the community of Fort mcKay.

Cultural programming in the region will be enhanced by the members of the community of Fort McKay participating in cultural events in the larger community and vice versa.

What is the community need that these operations/programming will address?
The Fort Mckay Recreation & Cultural Society encourages the members of the community to adopt a healthy lifestyle through, recreational, leisure and cultural activities and programmes.
Emphasis is put on providing programming, activities, and services for the youth of the community while programming is also provided for adults and elders. An increased need for programming for young adults (age 18+) has been recognized.
How was the need determined?
This need was determined though consultation and discussion with organizations such as the Fort McKay Sustainability department and other community groups such as Fort McKay MOM's Daycare. Fort McKay Wellness Centre, Fort McKay Youth Centre, and Fort McKay Elders Centre as well as discussion with interested individuals.
How will these operations/programs address this need?
The programmes will address this need by providing recreational, leisure and cultural activities, events, and oppourtunities that encourage a healthy lifestyle in the community.

## What do successful operations/programs look like? How do you know they are successful?

Success can be judged by participation in and the attendance at the programmes and special events that are provided. The amount of community participation is also evidence of success. The results of the the community cleanup and graveyard are apparent to the eye and add to the overall appearance of the community.

The success of art and pottery workshops are apparent as the final products of the participants are displayed. For example, a teepee on which the youth of the community painted a design under the direction of a noted aboriginal artist was prominently displayed during the Fort McKay First Nations Treaty Days

Training workshops have resulted in improved delivery of services.

## How are you measuring success (i.e. surveys, evaluation, longitudinal studies)?

Success is measured through word of mouth and discussion with participants in workshops, activities, and special events. The positive reaction to the results of workshops such as art and pottery are noted (see note re teepee design above) as is the enthusiasm evident at events such as skiing and tubing.

Discussions are held with cooperating organizations on an ungoing basis in order to determine the success of activities and programmes.

## Does these operations/programs duplicate or overlap with other operations/programs offered in the community? How is your organization's offering unique?

There is no duplication or overlap with other operations, activities or programmes offered by other organizations in the community because many of our programmes are planned and held in cooperation with these other agencies. Discussion and communication with the other groups and agencies is ongoing and needs that are lacking are determined.

Through contact and discussion with these other agencies unique programmes and activities are offered eg. painting of design on the teepee.

Please explain any cost savings initiatives the organization has, or is planning, to implement:

The Fort McKay Recreation & Cultural Society is a volunteer organization. The members of the board receive no renumeration and there are no paid employees. By cooperating with existing service providers in the community costs are minimized.
As of 2018, the Fort McKay Recreation and Cultural Society and the Fort McKay FCSS Society plan to work together as one organization under the Fort McKay Recreation & Cultural Society. The Fort McKay FCSS Society will be dissolved and the board members of that organization will be encouraged to join the board of the Fort McKay Recreation & Cultural Society. The programmes supported by the 2 organizations will continue. The budgets of the 2 organizations will be combined in order to support existing programmes as well as any new programmes that are identified. As a result, the programmes of the 2 organizations will be streamlined and there will be no duplication of budget items. The costs of bank services and office supplies will be reduced.

In a time of fiscal restraint, the Municipality would like to know how the organization is working towards a sustainability plan to ensure the operations/programming are continued, should the CIP's Community Operating Grant be decreased or eliminated in the future:

At this point the the funding received by the CIP's Community Operating Grant is essential to the operation of the programmes of the Fort McKay Recreation & Cultural Society. If this funding is decreased or eliminated there would be a resulting dcrease in the ability of the organization to support existing programmes. The Fort McKay Receation and Cultural Society will continue to contact possible corporate and/or public sector sponsors.

The residents Fort McKay who are mainly of First Nations and Metis heritage are encouraged to participate in recreational, leisure, and cultural programs and activities that take place in the community. However since facilities and oppourtunities are limited due to the size and rural location community members are also encouraged to participate in events that make use of recreational facilities in other parts of Wood Buffalo.

Fort McKay is a community in change and there are constant social pressures in play. The youth of the community are particularly affected and the Fort McKay Recreation and Cultural Society is working with other community groups and organizations to alleviate this situation.
