Foundation's 2009 survey. Youth who take part in extra- curricular activities tend to
be more confident, capable and committed to making the positive choices they
need to when they move into adulthood.





Community Impact

Youth Centers and structured teen programming play a valuable role in any community by empowering youth to make positive life choices, providing mentorship, opportunities for social interaction, community engagement, as well as individual support. Youth centers can promote a strong community- based identity. Our center not only provides a safe, supervised environment for teens, but we also connect youth to other community resources through our referral process to assist them with their current needs, whether that may be mental health support, employment opportunities or anything outside of our JSYF scope to help them accomplish their successes. We provide youth with an opportunity to engage in constructive and pro-social activities, reducing the risk of substance abuse, sexual activity and delinquent behavior. Prevention is key.

JSYF received financial support from the Canadian Red Cross, Bumper to Bumper, Royal Canadian Legion, Suncor Energy, Shaw Charity Classic and Spartan Controls throughout the last fiscal year.

JSYF will be appliying for Government of Alberta grants throughout this fiscal year, as well as re-applying to receive funds from the legion. In addition to the JSYF Annual Golf Tournament and Silent Auction fundraiser, JSYF will be hosting a gala in April 2018.

JSYF has also been accept as a member of the Birdies for Kids program with Shaw Charity Classic this year.

The main purpose of our strategic plan is to be recognized as the leading/ backbone organization for youth needs and opportunities by providing age- engaging activities, events and programming designed to promote self- esteem, build interpersonal skills, and promote youth involvement in our community to establish future leaders within the RMWB.

1) Find out what youth need, want and expect from JSYF to motivate youth attendance in all programming.

2) Develop a deeper understanding of the knowledge needs of youth within our community.

4) Create new opportunities for Fort McMurray Youth through partnerships with community service providers and organizations.

The Justin Slade Youth Foundation is a non profit organization that provides youth ages 12-17 with organized programs, community engagement, volunteerism and a casual drop in center that promotes valuable opportunities for social interaction.

For the past 13 years since inception, JSYF has proudly served the young people of Fort McMurray and the surrounding communities with programs and workshops to help better themselves. All programming is offered free of charge to any and all youth, regardless of what socio- economic status they may face.

Our mission is to empower the youth of our community.

Programming is offered on a structured and un-structured basis through the 3 different components that make up our foundation to ensure that we are meeting the needs of the youth in our community. We offer an unstructured drop in center geared towards social interaction amoung youth, an Annual Grade 8 Youth Conference in partnership with both the Fort McMurray Public and Catholic School Boards, and JSYF Presents which focuses on organized, structured activities and events outside of our home base within the different neighbourhoods in Fort McMurray.

Describe the elements, activities, or events of general operations that the organization is seeking this funding for:

The Dugout: This is our youth drop in center which is open 7 days a week to youth within the municipality. The Dugout provides a safe, clean and drug free environment to interact with one another and have fun. Our team of youth workers aim to build strong relationships with any and all youth who walk through our doors and provide them with the support they need as individuals to navigate their own positive journey through life. Today, the dugout has recorded over 12,000 contacts made into the drop in center, which the hopes of reaching more teens and keeping them away from harmful behaviour they may face if hanging out on the streets of Fort McMurray. Activities offered at the drop in include, yet are not limited to: pool, ping pong, air hockey, arts, crafts, homework help, computer access, resume building, life skills workshops, a reading corner, writing workshops, volunteerism, mentorship and much more.

JSYF Presents: This is the outide programming component of JSYF, offering multiple organized programs throughout the year at various locations located in Fort McMurray. Our foundation's goal is to always provide a full schedule of events and activities within the different areas of Fort McMurray while addressing and concurring the need of accessibility within our region. While many youth are fortunate enough to be able to travel to the different areas of Fort McMurray and take part in programming opportunities, this is not the reality for many. JSYF was designed to address transportation, cost and youth input. Activities involved include, yet are not limited to: Life Skills Workshops, Career Preparation Courses, Sports and Recreation Leagues, Creative Arts, field trips, Youth Cooking, Performing Arts, Camping Trips, Beach Days, bonfire nights, movie field trips and much more.

No Limits Youth Empowerment Day: An Annual Grade 8 Youth Conference in partnership with both the Fort McMurray Public and Catholic School Boards. This conference went from being a choice as to whether or not you'd like to take part, into being a mandatory conference each year. This way, we can ensure that we target youth at a young age in hopes to prepare them for a bright and successful future. With this change, the conference went from an average of 300 registrants per year, to 700+ each year.

Explain how the operations/programming will achieve the objectives of the Municipal Strategic Plan as indicated on page 4:

JSYF aims to provide age- engaging events and activities throughout the different areas of our region. With our drop in center being located in the downtown core in Borealis Park (The Haxton Center), we are able to target the youth population residing south of the bridge, offering activities/events/workshops 7 days a week, 362 days a year. Youth attending our drop in center have access to all activities located in Borealis Park, which includes a basketball court, s spray park, a skateboarding park, a walking track and a volleyball court. JSYF hosts special events outside in the park as we encourage youth to live a healthy and active lifestyle while interacting with their peers.

JSYF Presents offers free programming in various venues, including RMWB facilities throughout Fort McMurray. Facility usage includes school, Syncrude Athletic Park, Meadow Creek Community Village, Suncor Community Leisure Center, Suncor Energy Center for the Performing Arts, outdoor recreation areas and much more. It is extremely important to our organization to continue offering these programs free of charge as they are designed to promote self esteem, build interpersonal skills and promote youth involvement in our community as they get to know the different facilities and resources available to them without having to worry about financial barriers they may face.

What is the community need that these operations/programming will address?

Youth Centers play a valuable role in any community by empowering youth to make positive life choices, providing opportunities for social interaction, community engagement and individual support. Youth Centers promote a strong community- based identity. Our facility not only provides a safe, supervised environment for teens, but we also connect youth to community resources they will help them accomplish their successes. We provide an opportunity to engage in constructive and pro-social activities, reducing the risk of substance abuse sexual activity and delinquent behaviour.

With JSYF Presents providing youth with structured programs throughout Fort McMurray, we aim towards prevention. Youth who are involved in extra- curricular activities tend to be more confident, capable and committed to making better life choices and setting and achieving their goals in life.

How was the need determined?

This need was determined by the youth themselves, as well as parents and additional community members. Upon opening the foundation, much support was granted to JSYF as members of the community felt that Fort McMurray youth needed a place to be rather than the streets. After surveying youth in the schools back in 2009, feedback was given that youth did not feel like there were positive role models within our community, as well as feeling that they were not valued. By providing programs based on prevention and self esteem, JSYF is able to concur these obstacles that youth feel they face.

How will these operations/programs address this need?

The Dugout will address this need by provide youth with a safe, clean and drug free environment to be with their peers. The Dugout is open 7 days a week, 362 days a year to ensure we are always available for our youth.

JSYF Presents will continue to offer free programming to defeat any financial barriers youth/ families face when it comes to the costs of extra- curricular activities.

What do successful operations/programs look like? How do you know they are successful?

JSYF has a committee known the Y.A.C (Youth Advisory Committee). This committee consists of youth who help develop programming ideas and attend the majority of JSYF events to provide feedback and constructive criticism. JSYF takes the opinions of youth very seriously as we are here for them to set the up to be successful. Successful programs are based not only on stats, but on feedback from the youth themselves.

How are you measuring success (i.e. surveys, evaluation, longitudinal studies)?

Each program offered includes an evaluation at the end. Evaluation are always done at the Dugout on a bi-yearly basis.

Does these operations/programs duplicate or overlap with other operations/programs offered in the community? How is your organization's offering unique?

JSYF is a community- based organization that is inclusive to our community. JSYF is also known as the only organization that only focuses on youth. Many organizations within our community include a youth component, yet it is not their only mandate.

JSYF also chairs a committee known as Y- Connect, which consists of multiple organizations who meet on a monthly basis to encourage partnerships and collaborations, a steer away from the duplication of programming. This committee helps to keep each other informed of upcoming programs being offered to avoid duplication in services.

The Justin Slade Youth Foundation has a variety of funding needs. Funding, such as the Community Operating Grant, is needed to cover our expenses such as programming materials, venue rentals, staff, equipment, contracted work (keynote speakers/ facilitators/performers), etc. In the effort to sustain projects, provide accountability and continue to offering programming free of charge to youth, the foundation applies for and is continually researching new grant opportunties.

The Justin Slade Youth Foundation also fundraisers by hosting an Annual Golf Tournament and Silent Auction each June and will also be implementing a new fundraiser (Gala) in April, 2018.

The foundation is also a United Way funded agency and could not be more thankful for their support.

However, in order to provide free, quality programming for the youth of our community, the foundation is also reliant on direct donations. JSYF accepts individual and corporate donations, as well as gifts in kind.

The Justin Slade Youth Foundation continuously works on cost saving initiatives to increase our cash flow for operations of the foundation. These initiatives include the following:

Increasing in- kind donations: Using "in- kind" services helps the foundation to cut costs. Local business owners will often provide services as an in- kind donations such as discounts on office supplies or free services that the foundation usually pays for.

Using volunteers: Using volunteers for facilitating workshops and/ or programs is a great way for us to save on staffing costs, especially during summer hours when the foundation is at its busiest time of year. Many community members are willing to volunteer to provide services when they believe in the work and the effect that the foundation has on the community.

Partnerships/ Collaborations: JSYF continues to partner with other non- profit organizations to save costs on programming materials, supplies, facilitators, event space, etc.

Cost effectiveness of programs: Programming that JSYF has to offer costs the foundation money. JSYF will continue to review each program offered to ensure we are spending money in appropriate and efficient ways, or re-allocated money being spent towards other programs with more significance/ impact.
