unexpectedly I met two females, after I had conversation with these two females, I confirmed that one of the females was the SOC of the case: [REDACTED] dog walker/dog care taker of the attacker/dog.

\*\*\*\* At approx. 1340, I arrived the dog attack incident location:

- I saw the small dog already died on the last door step of the house with the leash was still on and tied to the door steps railing of [REDACTED]
- The dog owners, the kid's Mom and the 5 year-old son were crying inside the house and looked panicking, Mom holding the son.
- As per the complaint, the Mom did not speak much English, and the husband was called and on the way home from work.
- As per the info given by the complaint and the dog owner, the large dog came up to the door top door step where the small dog was leash on bite the small dog's head area, the dog walker was unable to pull or control the large dog from the attacking.
- The small dog family was given "Restitution package" and "Statement" paper to complete.

\*\*\*\* At approx 1530, I attended the attacker/ large dog's house. The dog owner (Ms. BRANNAN) was called the the dog walker and returned home from work. Both the dog walker and the larger dog owner were given "statement" paper to complete.

\*\*\*\* [REDACTED] did not present her valid or subsisting business license to be checked.

\*\*\*\* Dogs and people involving in the incident:

- Large dog owner: BRANNAN, Kellie, adopted this dog from "Boxer Rescues Canada" in Jan. 2018.
- Dog walker: [REDACTED] a contracted dog walker for Ms. BRANNAN's dog, Stanley. There was a business / service contract between these Ms. BRANNAN and [REDACTED] at the time of the incident.
- The large dog (attacker): Stanley. Male, 2.5 years old, Mastiff and Boxer Cross.
- The dog owner notified [REDACTED] that (Dog) Stanley was friendly to people but aggressive towards other dogs;
- Small dog's owners: [REDACTED] (the husband), [REDACTED] (the wife)
- The small dog (dead): Hatchy, male, 6 month old, Chihuahua, brought from Mexico by the dog owners.

\*\*\*\* Three charges made to [REDACTED] 4.05(B) Animal killed animal; 4.01(A) Animal at large; 3(1) Carry on or operate business without a valid and subsisting license.

\*\*\*\* Owner of Stanley was charged with 3.02 unlicensed dog for Voluntary payment.

\*\*\*\* As per Section 7 of the Municipal Government Act, the municipality grants the authority to the Chief Bylaw Officer to deem the dog (Stanley) , a Vicious Dog.
