These old guys were the original 3 McMurray Muskateers and with their blue Suncor jackets and caps they claimed their spot on that land a long time ago!


So in my mind and heart I think it's only fitting that something in that park be named after them using my late father's name.

I am re-submitting our application along with the request to attend your next decision making meeting to relate our family's reasons for wanting to do this.

Our father Raymond was a very long time local citizen of this community. We moved here in 1959 from Lac La Biche, AB. Our first home was on the 'Prairie' where the KFC is now located on Franklin Ave. Dad worked for NT in the ship yard. He then moved to GCOS and was one of their founding members working as the Carpenter Supervisor in Extraction.

Dad loved Fort McMurray! It was his home and he was proud of it. He spent his retirement years usually down at the Syne fishing and feeding the birds. Or you could find him at Mom's Kitchen in the River City Centre mall having coffee with all his old friends.

Dad volunteered as a Forest Fire Fighter during the summer season's. As noted on the first application dad was responsible for saving two children who had climbed up on the Abasand hill overlooking the Athabasca river. They were stranded about half way up, Dad climbed up to get them. He was always all over helping others out back in the day.

In addition to what's on the Length of Stay in the RMWB I will add that his grand-daughter Section 17 (1) FOIP owns her own business here in Fort McMurray. His other grand-daughter Section 17 (1) FOIP is finishing her degree's/doctorate's in Law & Political Science as I write this. Our whole family is still here, this is our home and we are loyal to our community just like dad taught us.

I could go on and on and toot my father's horn....but I won't. He was a true McMurrayite and deserves to have his name somewhere in this city. It will be a tribute that this great-great grandchildren can see and be proud for all our generations to come.
