**RE: Fort McKay First Nation - Additions to Reserve (ATR)**

Expanding Fort McKay First Nation reserve land through the addition to reserve process is essential to improving our community access to land and resources and is a necessary step for increased social and economic development for our members.

Fort McKay First Nation received conditional approval from Indigenous Services Canada (ISC) for the addition to reserve of 11 parcels of land within the Fort McKay community. We have satisfied the majority of ISC's conditions; however, in order to conclude the addition to reserve process we require the following from the Regional Municipality of Wood Buffalo:

- A letter of support for the proposed additions to reserve; and
- Commencement of negotiations of a Municipal Service Agreement for the ATR parcels, which will also address any tax-loss adjustments required by RMWB.

It is my understanding the proposed ATR parcels listed in the attached tables will be discussed during the July 14, 2020 RMWB Council meeting. I look forward to receiving confirmation of support from the RMWB, particularly Mayor Don Scott and Council. We have several Community focused land projects that we are planning to move forward over the summer. The Letter of Support will enable us to meet our timelines.
