

### **REQUESTED AMENDMENTS:**


- Align the ASP with direction contained within the new MDP relating to 'New Employment Lands' (Commercial and Industrial lands)

- Identify the Prairie Creek/Highway 63 Business Industrial area as a site with immediate development potential as per the MDP




#### **REQUESTED AMENDMENTS:**

- Explore implementation of piped water distribution and sewage collection in certain business industrial and commercial areas close to or within the Urban Service Area


